Shabbat Shalom, Richard -

I believe you have discovered the household information for Oscar Jr., who was raised by his grandmother Gertraud Falker. I have seen the Falker gravesite - it is very beautiful - but I know very little about them! Thank you for sending me this.

I stumbled upon a fascinating discovery myself yesterday that may be of interest to you. It appears that after Emanuel Friend's death, the families of his deceased siblings sued Michael Reese Hospital in 1951 for the substantial estate he left them. (It was appaerntly worth 2.4 million by then!) My grandmother, Sylvia Friend (Oscar Jr.'s widow) is named in the suit as supporting Michael Reese Hospital in this dispute. As history shows us that Michael Reese won this suit, I am *highly* suspicious that the reason my branch of the Friend family has been isolated from the rest is because of this. How sad . . .

I am busy researching who the offspring are below (I know that Rhoda Hecht Rubel is Nellie Friend's daughter). Here is the reference to the lawsuit. My mom is working with an attorney friend to try to get the complete version:

Hi Richard -

OK, I have added the picture of the Friend Pavilion as an attachment. (I have never actually seen it myself, this is from the internet.) I found the puctures of Max and Rose you had posted and they made me smile - thanks! Unfortunately, I know very little about Emanuel; but I am sending you what I found so far. I have read that he was an attending surgeon at Michael Reese and died of a heart attack on July 30, 1938 at age 68.

"A legal fight to obtain a widow's share of the \$2,000,000 estate of the late Dr. Emanuel Friend, noted Chicago physician, was begun yesterday by Mrs. Magdalen Friend Lanskop before Judge John J. Lupe."

Nov 27, 1940 - Testimony that the late **Dr**. **Emanuel Friend** considered his wife," mentally ill" featured the suit yesterday in Superior court where Mrs. Magdalen **Friend** Lanskop is seeking to have **Dr**. Illinois Appellate Court Reports FRIEND v. NORTHERN TRUST CO., 314 III. App. 596 (1942) Gen. No. 42,011. Opinion filed May 27, 1942.

On May 18, 1917 an antenuptial agreement was executed at Chicago between Emanuel Friend, a physician and surgeon of that city, and Magdalen Jane Alexander, whereby the latter purported to waive any and all rights in the estate of her intended husband for the sum of \$5,000 in the event the parties should separate prior to the husband's death, and the sum of \$25,000 in the event they continued to live together until his death. The parties were married at Chicago on May 26, 1917. At that time she was 24 years and he was 49 years of age. She received her education in a convent in the State of Iowa. (NOT JEWISH!) After completing her education and prior to her marriage to Dr. Friend, she gave lessons in speaking and taught art and elocution in Chicago. On December 8, 1933, Dr. Friend filed a bill for divorce in the superior court of Cook county. The bill alleged that on October 27, 1932, Magdalen Friend wilfully deserted and abandoned him for the space of one year and upwards. Magdalen Friend, answering, admitted the marriage, but denied she had deserted him. On December 13, 1933, the superior court of Cook county entered a decree finding that on October 27, 1932, Magdalen Friend wilfully deserted and abandoned Emanuel Friend without any reasonable cause therefor, and that she persisted in such desertion for the space of one year and upwards prior to the filing of the bill of complaint. The decree dissolved the marriage between the parties, and found that pursuant to an agreement the antenuptial contract of May 18, 1917, was terminated. Emanuel Friend was ordered to pay Magdalen Friend the sum of \$25,000 in full and complete settlement and adjustment of all her rights in the property of the complainant, and of all claims and demands for alimony and support. Emanuel Friend was also ordered to pay Magdalen Friend for her solicitors' fees and costs the sum of \$5,100, and to deliver to her one LaSalle automobile. The court further decreed that all the right, title, claim or interest of Magdalen Friend in any property then owned by him

Hope you find this as interesting as I did!

I would be interested in Emanuel's biography and also, just for curiosity, the source of wealth for Emanuel and Max if there are records or family traditions. If I were to prioritize my genealogical curiosity, the first question I would ask, however, would be the reasons for emigration. For example, were they fleeing European revolutions? Poverty? AntiSemitism? Military service? My premise is that statistically you would flee from, not toward, to leave a nation.

Greetings Richard -

Thank you so much for your gracious reply! I am new to genealogy and quite enjoying the puzzle. My family mystery has been my great-grandfather Oscar Friend, who died in 1897 before the birth of his only child. His wife Selma Falker died 2 months after the baby was born, and her parents raised the baby, who was named Oscar Jr. As this second Oscar died when my father was only 13, there has been really no oral history passed down.

However, I was delighted to discover only a few weeks ago that Oscar had many siblings!! I have since been playing detective online to find out as much as I can about their life stories. Here is what I have so far:

Your Uncle Max's parents were BERMAN and HANNA (nee Briedenbach) FRIEND, both born in Darmstadt Germany. Max's siblings were:

LENA - married Lipman Loser of Nashua Iowa, she died of Bright's disease (nephritis) in 1910, no kids.

NELLIE - married Joseph Hecht of Nashua Iowa.

EMANUEL - high profile physician in Chicago in early 1900's; Friend Pavilion at Michael Reese Hospital made possible through his estate (as is the Friend Early Alzheimer facility that opened more recently in Deerfield, IL.)

OSCAR - had one son, Oscar Jr. who had 3 children. The youngest of these was my father, James

<u>Friend</u> - he was Chairman of the English Department at Chicago State University until felled by a heart attack in 1987, at age 55. I am his younger daughter, and a psychiatrist at Lutheran General Hospital in Park Ridge IL. NATHAN - ? ALEXANDER - ? SOLOMON - ?

Do you recognize any of other names listed above? Was Rose's family not Jewish? Do you recall the name of the relative in England whose estate Max tried to save?

Again, thank you so much for sharing your personal memories of your great Uncle Max - who it seems is my great-great uncle as well!

Greetings Marla! I have a subscription to <u>Ancestry.com</u> but not to <u>Genealogy.com</u>. Great uncle Max Friend was beloved by all my Mandelbaum relatives and he and great aunt Rose (Hambujer-Friend) generously gave a stake to my grandparents Mandelbaum and their 4 daughters..my mother and her 3 sisters. The family tradition is that Max came from a huge family, made his fortune in real estate, had no children, and his brother Emanuel gave the Friend Pavilion to Michael Reese Hospital. There was a tradition also that Max hired a lawyer in the 1930's to go to England to rescue in vain a 40 million-dollar estate from a relative who had made it in a religion and who had been murdered in an airplane. Max died in 1948 and Rose a little later. They and my family were frequent visitors and when I was little uncle Max would always bring rolls of new pennies or nickels as a present for me and my sister. I still have photos of Uncle Max and Aunt Rose. My father was of English stock going back to the Mayflower, the Revolution, the War of 1812, and the Civil War. My Mandelbaums started with Aaron Mandelbaum from Gehaus, Germany who came here in 1852 on the clipper ship Orpheus with his brother Moses when Aaron was 18 years old. I am 83 and still practice medicine. Have 4 children, 2 step children, 15 grandchildren, was Lutheran, late wife beloved June died 1991, remarried, then joined a synagogue and taught Sunday School there. I have 70 years of genealogy online for anyone interested. Grandma Estella Mandelbaum was from Ephraim Hambujer (Hamburg) and Hannah (Anna) Darmstadt, in case you have any links to those names. I am inspired to find Jewish relatives, so I hope you keep writing.
