

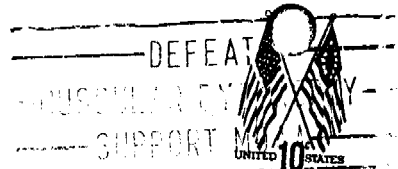

Interview with Roland Grayson

December 23, 1973

Uncle George Grayson and Aunt Mary and Gladys and Howard Demaree came to Chicago in 1947 and gave the Pap Grayson sign to Roland. This is the curved sign from the steam fire engine in Madison, Indiana, where John Wren Grayson was the captain of the fire company about 1850.

Uncle George was "nuts" on baseball, as were Howard Demaree and Gladys. George gave the Pap Grayson sign to Dad because Dad was the only Grayson in his generation. Uncle George was a mailman. Uncle Will worked at an icehouse in Shelbyville after he retired. Dad (Roland) was a Methodist. Dad was born in Indianapolis.

Howard had no middle name. He worked as a clerk in a grocery store. Most of the grocery business was by delivery – twice a day. He met Una Mae in Indianapolis and was married in 1902, moved brought to Chicago in 1905 – Dad was age 2. Howard and Una Mae moved to Chicago to be near the Wahlgrens (her mother and stepfather).

Howard had a job with Todd and Gerkhe grocery store on Broadway near Belmont. He moved in with Grandma Wahlgren at first, then rented 1900 block on Western Avenue, 1905 – 06. Then Grandma Grayson built a house with money she inherited from Uncle Lafa (Lafayette Heidell) next to her mother's house at 4824 Bell Avenue.

Dad lived there eleven years and got married at age 21, June 1, 1924. Born – April 15, 1903. Mother born - April 27, 1905.

Howard earned \$19.00 a week at first. Howard had two years of high school. At age 12 –13, Roland and Ward had a refreshment stand at Lawrence and Lake and sold refreshments to the bathers.

Roland "refused to be poor", so he went to work after graduating from grade school. He went to work at Sheridan Trust and Savings Bank at Lawrence and Broadway at age 15. His job was to carry a 32 and a 38 – two pistols with over \$50,000 to the Loop. His parents encouraged him to quit school so they could get room and board from him to help support the three sisters.

Dad went to the Methodist Church because it was close. Dad was a printers devil one summer, age 13-14 at a Methodist Book Concern. Howard and Una Mae went to church only when they had to.

Howard worked 7:00 a.m. to 7:00 p.m., seven days a week and had so little time at home. He did not want to go to church.

Roland never heard of John Wren Grayson until recent years – only knew about Andrew Jackson Grayson.

As a youth, Dad visited Uncle Frank Grayson in Madison, Indiana who owned a corner grocery store. Frank went broke there, ended up in California. Dad saw Ellsworth Grayson – who died early.

Howard knew about cousins of his own age on several farms around Madison, but Roland remembers no more than this.

My father, Roland thinks that there must have been an Indian in the Tasker line because

- 1.) Una Mae had high cheekbones, dark skin.
- 2.) Likewise, her daughter, Virginia.
- 3.) Roland had no beard on the side of his face and never had to shave more than every two days.

Una had no sisters and brothers. Grandma Wahlgren was a Tasker first – got divorced – around Boston. Grandma Wahlgren did not have an Indian appearance. She had only one sibling – Uncle Lafe Heidell – my great great uncle.

Howard moved to Indianapolis from Madison – does not know where. Why did they go there? Note that, (I think), Aunt Lottie (Grayson) and Ward Jones lived in Indianapolis.

Uncle John Jones owned the Hoover Vacuum Cleaner Company office for the district (five stores) office in Chicago. Howard belonged to a racing bicycle club in Madison when grown.

Roland got a job at the Hoover Company at age 16 in Chicago where he learned to repair and sell vacuum cleaners. When he was 22, he was service manager. The Hoover Company dissolved the District office and everybody was thrown out of work. Ward had a separate business selling bumpers for cars – bumpers were accessories at that time.

IN THE NAME OF GOD, AMEN.

I, HOWARD GRAYSON, of the city of Chicago, County of Cook and State of Illinois, being of sound mind and memory and considering the uncertainty of this frail and transitory life, do therefore make, ordain, publish and declare this to be my last will and testament, hereby revoking all former wills by me made.

FIRST: I order and direct that my executrix hereinafter named pay all my just debts and funeral expenses as soon after my decease as conveniently may be.

SECOND: All the rest, residue and remainder of my estate, real, personal and mixed and wherever situated, I give, devise and bequeath unto my wife, UNA MAY GRAYSON.

THIRD: But in case of the death of my said wife prior to my death, then I give, devise and bequeath the said rest, residue and remainder of my estate unto my four children, viz., ROLAND H. GRAYSON, DOROTHY SMITH, VIRGINIA DANIELSEN and LOTTA MAY SEILER, to be equally divided among them, share and share alike; but in case of the death of any of my said children prior to that time, leaving child or children surviving, then the share of such deceased child of mine to be equally divided among such children; but in case of the death of any of my said children prior to that time, leaving no child or children surviving, then the share of such deceased child of mine to be equally divided among the survivors of my said children, share and share alike.

FOURTH: I make, constitute and appoint my said wife, UNA MAY GRAYSON, executrix of this, my last will and testament, and request that she shall not be compelled to give any bond or security as such executrix.

In case of the death, resignation, refusal or inability to act of my said executrix, then I do hereby appoint my children, ROLAND H. GRAYSON and DOROTHY SMITH to be successor-executors of this, my

employing all the capital and property which may be employed therein at my death, during the course of administration of my estate, in her or their discretion.

If at any time during the course of administration of my said estate my said executrix, or her successors, may deem it for the best interest of my said estate to sell said business and the good-will thereof and the property which may be employed therein, or any part thereof, then I give my said executrix or her successors, full power and authority to sell the same or any part thereof at such price or prices and terms as she or they may deem best and execute all deeds of conveyance or other instruments necessary and proper for that purpose, and the purchaser or purchasers at any such sales shall not be compelled to see to the application of the purchase money, and I direct that my said executrix, or her successors, making any such sales shall not be compelled to give any bond or security therefor, and I hereby give my said executrix, or her successors, full power and authority to compromise and compound any and all claims, either in favor of or against my estate and to give all proper releases, discharges and acquittances therefor which shall be valid and binding upon my estate.

She was preceded in death by her parents; a granddaughter and two sisters, Theresa Lewis and Anna Lans.

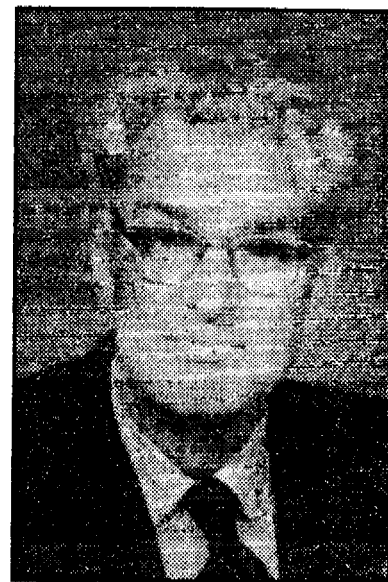

New Years Eve found us all apart. Mother
and Dad stayed home, listened to the radio and
went to bed.

Dot, who was expecting her baby any day, and
Fred, decided to stay at home-changed their minds
and went downstairs to Harold and Betty's, and
from there, visiting until 5 o'clock in the morn-
ing.

Gin and Hakon went to a big party someone at
Hartman's gave, and got plenty potched.

Lotta May was very sick, high fever and caked
breast, had Dr. Rose in and then just because it was
New Years Eve-got out of bed and went to Ler-
raine's house to celebrate.

Roland, who had chills and stomach ache, and
Sylvia went to Lucille and Henry's party. Roly
was sick New Years Day, too.

New Years day was spent apart and quietly by all.

January-the big news is the birth of Gene Fred Howard (they got five dollars extra for tacking the last one on) Smith, who punched the clock at 8:37 a.m. Wednesday, Jan. 7, 1942. Hurrah! a boy- the second out of ten grand-children. Dorothy and the baby came through fine, only for Gene almost being born in the hall because "fat Nurse Murphy couldn't squeeze through the door with the cart.

Jan. 11---Mother, Dad, Fred, and Diane came to Roland and Sylvia's for five o'clock dinner. Dot was in the Martha Washington Hospital. Hakon and Gin drove in to see Dot and Gend-had supper at Lotta and Jim's and in the evening all drove out to Sylvia and Roland's.

We are all stunned by the treachery of Pearl Harbor. Last month, Dec. 7. Everybody is patriotic and offering to do their share.

February, this month is full of bad news. Singapore is on fire-Japs are in the city-Mac Arthur the valiant and courageous general of the Phillipines-still holding out but at such a cost. The German fleet sailed sublimely past the British in their own front yard-the English channel and escaped the German resistance in Russia is getting stronger.

Roland and Hakon have to register-all men from 18 to 45 this time.

Sylvia's mother has a close call-heart attack-Priscilla has bronchitis-Roly sick in bed for 2 days, too. Dick came home from school to take care of store.

Feb. 8. Jean and Joan had their second birthday party-all were invited and went to Racine, but Roland's

family who were sick at the time. Gin had baked ham and birthday cake, etc.

Feb. 15--Suzy was christened Suzanne Carol Seiler, today--at the Episcopal church. Roland, Dorothy, Lois, Jim's sister, and Junior, Jim's brother, were sponsors. Because Junior is at camp he served by proxy. Lotty had a christening party for the Seilers. Gin and Hak and Aunt Magda didn't come in--Dot and Fred went home and Syl and Roly had supper at Mother and Dad's.

This month nobody reported much else but Roland bought a new mattress and decorated their bedroom.

March--Not much to write about this month. Mother Grayson had a birthday Mar. 7, and celebrated with a party. All the third generation was left at home excepting Gin's. Her children were asleep upstairs. We had a hilarious party--Aunt Magda, Mother and Dad, too--records were made--good lunch served--beer--wine, and just plain craziness and how we liked it.

April--lots of things this month. Gin and Hakon order new carpeting. Lotty and Jim rent a new apartment at Foster and Learrett--on the 3rd floor--they sublease their other--also they buy lots of new furniture and a new Maytag Washer. Dot and Fred get new tenants--have the apartment downstairs all redecorated and floors sanded--do lots of spring gardening.

Roland and Sylvia get a new 9 cubic foot Norge refrigerator and have their driveway repaired. Mother and Dad have decorating and cleaning.

On April 15, Roly had a birthday party. All Graysons, Seilers, and Smiths present--not any Danielsens, though. Backrat was played--beer pop corn and birthday cake and coffee to say.

April 21 is Mother and Dad's anniversary the 40th. All the kids chip in and buy tickets for Elithe Spirit. They didn't like it and Dad had a good sleep--all through it.

April 25th--Rol, Syl, Dot, Fred, Lotta, and Jim, Gin, and Hak, celebrate Syl's birthday at the Casa Nova. Have lots of fun. Go to Cleons and the Sky Club and then home. Gin and Hak, Marilyn, and Nancy come in Saturday afternoon, had chop suey supper at Syl's, went to the party at night and slept in Pat's room--went to the Haywood Nursery Sunday morning--bought bushes, had roast lamb dinner--went to Brookfield Zoo in the afternoon and after an early supper went home. The twins couldn't come in, due to temperatures from their vaccinations.

May. Lotta moves to new apartment and stay with Mother and Dad while the paint dries. Nellie Hilliard dies in horrible fire--Marilyn has a birthday. Aunt Magda has Roland's family, Gin's family and Mother and Dad for Sunday--Mothers Day. Wonderful dinner. Plans are discussed for Decoration Day family picnic.

Everybody drops in by accident at Mother's and we have hilarious supper party. More plans are made for Dec. Day.

Decoration Day arrives--blistering hot. Gin and Hak have car trouble and are quite late. Hakon spends greater part of day repairing car. Everybody brings their own lunch. Lotta and Jim, Suzy, and Aunt Magda don't come at all. We have picnic at Fullersburg. In the evening Dot, Fred, Gin, and Hak, Lotta and Jim go to So Ju Club.

June. Diane gets a new bed--Gene has Diane's now--Pat and Dick get new dressers--Pris gets

their old ones. Ginny spends a week at Moth and Dad's.

We have now lost the Phillipines, the most heroic battle of all times has been fought--the Epic of Bataan in which 110 Maywood boys have played a gallant part--Correigdor has fallen--Singapore--Hong Kong, Kowloon, Java--All gone to the yellow devils. Doo Little has bombed Tokio, the Russians are on the offensive and are mopping up Hitler's army. Mac Arthur is in Australia, taking the offensive--we have sunk 250 Jap ships and have lost over 150 of our own.

July.

Tabrus has fallen to the Axis--Aleutian Islands have been invaded by the Japs--Russia is again seriously threatened. Over 400 of our ships have now been sunk, some so close to shore that people on the beaches could watch them sink. Churchill has been here for a third visit with the President. The big scrap rubber drive is in progress--all gas stations are depots--tin cans and tubes are being collected--4,500,000 men now in the armed forces, bicycles unfrozen but rationed

Moth and Dad went to Aunt Betty and Uncle Will's for the 4th of July at Danville. They have a picnic and all Aunt Betty's children come. Aunt Magda took Marilyn and Nancy to Lake Geneva for a vacation. Diane has the big adventure this month. Runs away to buy her Mother a loaf of bread. Is gone from about 3 to 6:40--police and neighbors and relatives all searching--finally found at Hillman's--past Devon and Western--identified by Dad Grayson.

Pris falls down front steps on her nose--Roly has tooth pulled--Gin still waiting for carpeting. Roly and family visit Pell Lake and Eleanor and Melbourne.

August. Pat has her 15th birthday. Ginny gets her carpeting. Pris has kidney infection.

Lotty announces her pregnancy and buys a new cocker spaniel. Gene now crawls--so does Suzy. Penny has 10 pups.

Sept. Dpt and Fred spend their birthdays at Virginias from Sat to Mon night. Over the Labor Day Holiday. Syl and Roly have a new fence put up. Maywood has Bataan Day--the biggest event this little town has ever stayed. Kiane has her 3 yr. old birthday party. Mother and Dad go to Madison, Indiana to visit Aunt Mame and Uncle George and bring them back here. All of us entertained them.

October--The big event this month was Dad's birthday party and Gene's christening party held at Moth and Dad's house. Gene was christened at Berry church. No children were invited. Aunt Magda was sick with a cold and laryngetis and ~~sk~~ didn't come. Ginny had severe burns from some X Ray treatments for warts--infection had set in. The folks were worried and called in Dr. Rose.

The war news--the big Soloman Islands a battle Aleutian Island battle--victories for us--hurrah! Meat and coffee is scarce, tires are being bought by the government, gas rationing scheduled--18 to 19 yr. old draft law goes thru--also big income tax law. The great siege of Stadingrad is on. 60 days so far and the Russians still hold.

November. Lotty and Jim spend weekend in Racine. All together at Moth and Dad's for Sunday afternoon--again an unplanned but pleasant visit. Jim and Lottie go the Seilers for supper--Dot and Fred ~~etc~~ go home--Roland's and Gin's family stay. Gin's hands are better. Next Sunday Roland's family and Moth and Dad spend at Gin's house in Racine and following Sunday are at Roly's house in Maywood. Dot and Fred come out in evening.

Suzy has her first birthday party--walks and runs all over. Mother has Thanksgiving dinner.

Dot's, Lotta's, and Roly's family there-Gin's family with Aunt Magda in Racine. Dot still waiting--all Oct. and Nov. for decorators. They have nice tenants. Big decision made--no Christmas gifts at all except to folks.

Great victories to be thankful for--Solomons, New Guinea--inspiring invasion of North Africa. Alaskan news scarce--Japs are back at Attu but nothing else. Ruccian's strength increases, 100,000 Nazis killed, captured or wounded--in Stalingrad siege according to Thanksgiving paper.

December 8, 1942

And now as this history is being written and finished early so Fat can type it at school before it is closed for the holidays, let me summarize as well as I can what this month will bring.

Coffee was rationed Nov. 29, Gas and fuel oil the same week--sugar last May, bicycles in July--butter and meat are due next month and better so. People buy large quantities the minute the meat is displayed and in our town, Maywood, two stores had "no meat left for Monday's customers--no butter left at any stores Saturday afternoon. With rationing we all share alike. All of us are buying what stamps and bonds we can.

Christmas is this month--not as cheery as last--no gift wrappings to be strewn about, no whold family clan. Gas rationing will keep the Racine family there, Lotta, Jim, and Suzy are spending their day at the Seilers. The Smiths and Mother and Dad are having Turkey at Roland and Sylvia's.

Dot and Fred finally have the decorators, Roland and Sylvia have carpeting ordered and

ho hope the carpet man can find enough to do
the job. Ginny is better and Lotty is "waiting".
Next year at this time we'll have the eleventh
child to talk about. Enough for this year--
all is well.
